## ADOPTION AGREEMENT

I acknowledge receiving the animal described herein as an adopted pet. I agree that this is a document, which I sign for all members of my household, and we do all hereby agree to be bound by the terms of this agreement.

If the animal proves unsatisfactory, for any reason, it may be returned to Sapphire Cats Inc (SCI). I will provide proper care for this adopted pet(s). Proper care is defined as: proper housing, fresh water daily, food, grooming, exercise and proper health care. Proper health care is defined as immediate veterinary care in the instance of illness or injury. In the instance of a "special needs" animal, I also agree to make proper arrangements for regular and proper treatment of whatever special need(s) it may have.

I will comply with all laws and ordinances in force in the area in which I reside that are applicable to this adopted pet(s). I will not use this animal or allow it to be used for experimentation or food. I will not de-claw this adopted pet(s) and will keep the adopted pet(s) indoors only and the adopted pet(s) will not be allowed to roam freely outside of my home. SCI does actively support microchipping.

I agree that if SCI finds that the cat(s) have been de-clawed even after this document is signed, unless agreed upon by medical necessity in writing with SCI the cats will be removed from the home at my expense and a \$1000.00 fine will be due and payable immediately to SCI. If the fine is not paid, SCI will take legal action to gain repossession of the cat and seek the fine due plus all legal expenses incurred in this action taken.

I agree that, after signing this agreement, I am wholly responsible for this adopted pet(s) and hold SCI harmless for any future action, legal or otherwise, regarding same.

In the future, should I be required to relinquish ownership of this adopted pet(s) or can no longer properly care for it, due to any circumstance, I agree to return the animal to SCI for subsequent care and re-placement.

I agree to give SCI pre-arranged visitation rights post-adoption to ensure that the terms of this adoption agreement are being observed. Visitations will be requested with advanced notice and agreed upon by the adopter before any member of SCI would ever come visit the adopter's residence. Visitations will be made in advance with the adopter at a date and time agreeable to both parties.

I understand and agree that SCI makes no representations or warranties, expressed or implied, about the adopted pet(s) temperament and is hereby absolved from any liability for future damages or injuries caused by said animal.

I understand and agree that SCI further gives no guarantees, expressed or implied, of the suitability of the animal to the adopter and/or his/her family.
