

# TRIAL PERIOD ADOPTION AGREEMENT

I have physically taken said cat(s) into my possession for a trial period to determine suitability for my family/self. This trial period has been offered to me to make sure the cat(s) I am interested in adopting is the best cat(s) for me and my family/self. This trial will only last for 60 days from today's date.

I acknowledge receiving the animal described herein as a trial-period adopted cat(s). I agree that this is a document, which I sign for all members of my household, and we do all hereby agree to be bound by the terms of this agreement.

If the animal proves unsatisfactory, for any reason, it will be returned to Sapphire Cats Inc (SAPPHIRE CATS). I will provide proper care for this trial-period adopted cat(s). Proper care is defined as: proper housing, fresh water daily, food, grooming, exercise and proper health care. Proper health care is defined as immediate veterinary care in the instance of illness or injury. In the instance of a "special needs" animal, I also agree to make proper arrangements for regular and proper treatment of whatever special need(s) it may have.

I will not use this animal or allow it to be used for experimentation or food. I will not de-claw this trial-period adopted cat(s) and will keep the trial-period adopted cat(s) indoors only and the trial-period adopted cat(s) will not be allowed to roam freely outside of my home. SAPPHIRE CATS does actively support micro chipping.

I agree that if SAPPHIRE CATS finds that the trial-period adopted cat(s) have been de-clawed even after this document is signed, unless agreed upon by medical necessity in writing with SAPPHIRE CATS the cats will be removed from the home at my expense and a \$1000.00 fine will be due and payable immediately to SAPPHIRE CATS. If the fine is not paid, SAPPHIRE CATS will take legal action to gain repossession of the cat and seek the fine due plus all legal expenses incurred in this action taken.

I agree to give SAPPHIRE CATS pre-arranged visitation rights post-adoption to ensure that the terms of this adoption agreement are being observed. Visitations will be requested with advanced notice and agreed upon by the adopter before any member of SAPPHIRE CATS would ever come visit the adopter's residence. Visitations will be made in advance with the adopter at a date and time agreeable to both parties.

I understand and agree that SAPPHIRE CATS makes no representations or warranties, expressed or implied, about the trial-period adopted cat(s) temperament and is hereby absolved from any liability for future damages or injuries caused by said animal. I understand and agree that SAPPHIRE CATS further gives no guarantees, expressed or implied, of the suitability of the animal to the adopter and/or his/her family.

I understand that after the 2 month (60 days) trial period has ended I will advise SAPPHIRE CATS of my intentions to permanently adopt the cat, return the cat or request an extended trial period.
